

1. Tickets. \$100.00 each. Each participant who purchases a Draw Down Ticket ("Ticket") will receive an 8 x 10 photograph signed by a former Ohio State University athlete. When you purchase a Ticket, you will be emailed a number which will be used to determine the finalists for the Grand Prize drawing. A maximum of 250 tickets will be sold. If there is adequate demand, UCAS reserves the right to sell additional tickets and offer a second Grand Prize. Your picture will be available for pick-up at the Battle of Bands June 6, 13, 20 & 27th. If you are not going to be present at any of the battle please e-mail rt4farmtour.com to make arrangement to receive your photo. All ticket Sales end on June 27th, 2024. Or until sold out.
2. Grand Prize. By purchasing a ticket, you will also have a chance to win the Fundraiser's grand prize: a custom Ohio State University Golf Cart (the "Grand Prize").
3. Battle Dates. Drawings to determine the finalists for the Grand Prize drawing will be held on the following dates (each referred to as a "Battle Date"): June 6, 2024; June 13, 2024; June 20, 2024 and at the finals on June 27, 2024.
 1. How to Qualify for the Grand Prize Drawing.
